Ladies and Gentlemen:

**RESOLUTION: SUPPORTING LEGISLATION MANDATING
PAYMENT BY MUNICIPAL EMPLOYEES OF THE EMPLOYEE
RETIREMENT CONTRIBUTION FOR THE WISCONSIN
RETIREMENT SYSTEM**

WHEREAS, Wis. Stats. § 40.05(1) provides for employee retirement contributions toward the Wisconsin Retirement System by municipal employees in the State of Wisconsin; and

WHEREAS, many Wisconsin municipal employers are contractually bound under the Municipal Employment Relations Act to pay the employee retirement contribution to the Wisconsin Retirement System; and

WHEREAS, due to the economic climate and reductions in the Shared Revenue Program, municipalities are facing funding shortfalls; and

WHEREAS, employees in private employment generally participate in the funding of private employment retirement plans; and

WHEREAS, legislation mandating that municipal employees be required to pay the employee retirement contributions toward the Wisconsin Retirement System would aid municipalities in funding shortfalls in municipal budgets.

NOW, THEREFORE, BE IT RESOLVED, the Brown County Board of Supervisors urge the Wisconsin legislature to pass a law mandating that employees be required to fund the employee retirement contributions toward the Wisconsin Retirement System.
